**From West:**

Take I-80/90 East to I-75 South to I-475 West to Exit 2. At top of ramp turn left and at the second stop light turn right onto Levis Commons Blvd.

**From East:**

Take I-80/90W to I-75 South to I-475 West to Exit 2. At top of ramp turn left and at the second stop light turn right onto Levis Commons Blvd.

**From South:**

Take I-75 North to I-475 West to Exit 2. At top of ramp turn left and at the second stop light turn right onto Levis Commons Blvd.

**From North:**
